

# First Two Weeks of July

- You will receive a Conversion Guide containing important account information.
- Update your personal information with Baker to ensure you can enroll in First Commonwealth's Digital Banking.

### Friday, July 22nd

- Bill Pay payments due between July 22nd 28th must be scheduled before 12:00 pm on July 22nd.
- Bill Pay and Mobile Deposit will be unavailable for a period of 12 days, beginning Friday, July 22nd at 12:00 pm through Tuesday, August 2nd (requires enrollment in First Commonwealth's Digital Banking).

## Last Two Weeks of July

- You will receive your new Visa® Debit Card (if applicable).
- You will receive your new First Commonwealth checks (if applicable).
- Your Baker debit card will work through Sunday, July 31st. Please discontinue use and safely dispose of your Baker card after this date.

### Thursday, July 28th

• The last day Bill Pay payments will be processed is July 28th, including any recurring or future-dated payments.

First Commonwealth Federal Credit Union cannot guarantee any payment that is scheduled to be processed beyond July 28th.

## Friday, July 29th

- Your Phillipsburg Financial Center will close at 5:00 pm on July 29th to begin the conversion.
- Last day to access Baker's BART system is July 29th at 5:00 pm. Members can begin using First Commonwealth's TellerPhone system starting Tuesday, August 2nd.
- No transfers or payments in Baker's Online Banking will post after 5:00 pm on July 29th. If you have payments on a Baker loan due between July 30th and August 2nd, please make arrangements to use an alternative payment method.
- Be sure to print or save your account history for your records prior to 5:00 pm on July 29th.
